**ORDER**

The Appellant is proceeding *pro se* in this appeal. He is appealing convictions he received for driving on a suspended license, violation of the financial responsibility law and violation of registration law. The Appellant filed notice of appeal on or about April 19, 2023, but the record has not yet been filed. He previously moved the Court to be declared indigent, but thereafter withdrew that request. Thus, on June 16, 2023, the Court ordered the Appellant to pay the applicable \$550 filing fee for this appeal within thirty days of the date of this order or face dismissal of his appeal. Tenn. R. App. P. 6(a). In the meantime, the trial court clerk notified this Court on June 22, 2023, that the Appellant had failed to file the transcript or statement of the evidence. Tenn. R. App. P. 25(a).

On July 24, 2023, the Court afforded the Appellant one final opportunity to respond and directed him, within fifteen days, to pay the \$550 filing fee and also state in writing whether he intends to file a transcript or statement of the evidence. Tenn. R. App. P. 24(b). The Court's order provided that the Appellant's failure to comply will result in the dismissal of this appeal. To date, the Appellant has not paid the filing fee or stated whether he intends to file a transcript or statement of the evidence. Accordingly, this appeal is hereby dismissed. Costs are taxed to the Appellant.

The Clerk shall forward a copy of this order to the Appellant and the trial court clerk.

**ORDER**

On September 18, 2023, the Court dismissed this appeal.
